ABOUT ARC SCHOLARSHIPS:

Recreational Program:

(includes Summer Intro Camps, Summer Recreational Camps, Non-Racing Team, Middle-School Team)
Austin Rowing Club will award 100% or 50% scholarships for these programs.

Racing Program:

(Includes Racing Team plus regular season Travel Expenses - excluding food, excluding National Championships)

Austin Rowing Club may award 100% scholarships ONLY to participants who have completed one successful year on the non-racing team or the middle school program. Rowers may also be awarded 75%, 50% or 25% scholarships

Priority consideration deadline for FALL competitive programs is August 15th by 11pm,
Rolling deadline of September 3rd for competitive programs.

Priority deadline for FALL Recreational Programs is October 28th.

Notification happens on August 19th for those who have met the priority deadline.
Scholarships awarded in the fall are automatically renewed for the spring. However, this form MUST be resubmitted prior to fall season annually.

Priority deadline for Spring – January 2nd 11pm – rolling deadline **TBD**.
Notification on January 6th for those who have met the priority deadline.
